

Delaware Manufactured Home Relocation Authority
Financial Summary – Cash Basis
August 2014

Revenues

The Delaware Manufactured Home Relocation Authority (the Authority), has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during August 2014 totaled \$5,959.50. Additionally, \$1,833.65 in interest was posted to the Trust Fund in August 2014 for cash held during July 2014.

For the fiscal year, total assessments collected are \$181,413.42 and total interest received is \$3,821.33 (page 3).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$7,830,581.31, total interest received is \$379,038.01, other income received is \$4,500.00, and total special collections are \$8,050.00 (page 4).

Expenditures

The Authority paid \$0.00 of relocation assistance during August 2014. The Authority paid personnel costs and bills for professional services, office expenses, and utilities during August 2014 totaling \$8,530.16 (page 3).

For the fiscal year, the Authority has paid \$0.00 of relocation assistance; \$6,843.82 in personnel costs; \$927.61 in occupancy costs; and \$8,499.78 in general and administrative costs (page 3), of which \$500.00 is related to arbitration costs.

Since inception on April 1, 2004, the Authority has paid \$572,714.59 of relocation costs; \$229,990.87 in personnel costs; \$40,407.48 in occupancy costs; and \$777,079.58 in general and administrative costs, of which \$500.00 was used to set up a petty cash account for daily incidentals (page 4).
