Financial Summary – Cash Basis
April 2016

Revenues

The Delaware Manufactured Home Relocation Authority (the Authority), has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during April 2016 totaled \$241,541.72. Additionally, \$4,134.49 in interest was posted to the Trust Fund in April 2016 for cash held during March 2016.

For the fiscal year, total assessments collected are \$1,173,517.23, arbitration fees received are \$2,250.00, and total interest received is \$33,071.65 (page 4).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$9,697,809.80, total interest received is \$436,727.09, arbitration fees collected are \$10,250.00, and total special collections are \$8,050.00 (page 5).

Expenditures

The Authority paid \$7,900.00 of relocation assistance during April 2016. The Authority paid personnel costs and bills for professional services, office expenses, and utilities during April 2016 totaling \$5,848.03 (page 3).

For the fiscal year, the Authority has paid \$730,934.48 of relocation assistance; \$33,199.99 in personnel costs; \$8,140.04 in occupancy costs; and \$59,251.90 in general and administrative costs (page 4).

Since inception on April 1, 2004, the Authority has paid \$1,870,766.62 of relocation costs; \$297,835.08 in personnel costs; \$57,678.74 in occupancy costs; and \$913,989.00 in general and administrative costs, of which \$500.00 was used to set up a petty cash account for daily incidentals (page 5).
