Financial Summary – Cash Basis
April 2015

Revenues

The Delaware Manufactured Home Relocation Authority (the Authority), has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during April 2015 totaled \$22,498.00. Additionally, \$2,408.29 in interest was posted to the Trust Fund in April 2015 for cash held during March 2015.

For the fiscal year, total assessments collected are \$585,012.42, arbitration fees received is \$3,500.00, and total interest received is \$22,575.24 (page 4).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$8,234,180.31, total interest received is \$397,791.92, arbitration fees collected is \$8,000.00, and total special collections are \$8,050.00 (page 5).

Expenditures

The Authority paid \$92,200.00 of relocation assistance during April 2015. The Authority paid personnel costs and bills for professional services, office expenses, and utilities during April 2015 totaling \$17,287.59 (page 3).

For the fiscal year, the Authority has paid \$308,900.00 of relocation assistance; \$35,658.68 in personnel costs; \$8,483.30 in occupancy costs; and \$64,062.91 in general and administrative costs (page 4), of which \$500.00 is related to arbitration costs.

Since inception on April 1, 2004, the Authority has paid \$881,614.59 of relocation costs; \$258,805.73 in personnel costs; \$47,963.17 in occupancy costs; and \$832,642.71 in general and administrative costs, of which \$500.00 was used to set up a petty cash account for daily incidentals (page 5).
