Delaware Manufactured Home Relocation Authority Financial Summary – Cash Basis July 2015

Revenues

The Delaware Manufactured Home Relocation Authority (the Authority), has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during July 2015 totaled \$262,751.92. Additionally, \$2,844.47 in interest was posted to the Trust Fund in July 2015 for cash held during June 2015.

For the fiscal year, total assessments collected are \$262,751.92, arbitration fees received is \$0, and total interest received is \$2,844.47 (page 4).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$8,791,544.49, total interest received is \$406,499.91, arbitration fees collected is \$8,000.00, and total special collections are \$8,050.00 (page 5).

Expenditures

The Authority paid \$132,668.09 of relocation assistance during July 2015. The Authority paid personnel costs and bills for professional services, office expenses, and utilities during July 2015 totaling \$5,228.52 (page 3).

For the fiscal year, the Authority has paid \$132,668.09 of relocation assistance; \$3,636.12 in personnel costs; \$810.02 in occupancy costs; and \$782.38 in general and administrative costs (page 4).

Since inception on April 1, 2004, the Authority has paid \$1,272,500.23 of relocation costs; \$268,271.21 in personnel costs; \$50,348.72 in occupancy costs; and \$855,519.48 in general and administrative costs, of which \$500.00 was used to set up a petty cash account for daily incidentals (page 5).
