

Delaware Manufactured Home Relocation Authority
Financial Summary – Cash Basis
October 2017

Revenues

The Delaware Manufactured Home Relocation Authority (the Authority), has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during October 2017 totaled \$279,762.11. Additionally, \$3,630.53 in interest was posted to the Trust Fund in October 2017 for cash held during September 2017.

For the fiscal year, assessments collected totaled \$570,123.47, arbitration fees collected totaled \$500.00 and interest received totaled \$18,156.54 (page 4).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$11,528,402.52, total interest received is \$540,477.65, arbitration fees collected is \$20,360.40, and total special collections are \$8,050.00 (page 5).

Expenditures

The Authority paid \$8,000 of relocation assistance during October 2017. The Authority paid personnel costs and bills for professional services, office expenses, and utilities during October 2017 totaling \$15,580.60 (page 3).

For the fiscal year, the Authority has paid \$87,250.00 of relocation assistance; \$19,503.08 in personnel costs; \$3,367.14 in occupancy costs; and \$38,317.64 in general and administrative costs (page 4).

Since inception on April 1, 2004, the Authority has paid \$2,265,016.62 of relocation costs; \$368,322.71 in personnel costs; \$72,945.00 in occupancy costs; and \$1,079,743.69 in general and administrative costs, of which \$500.00 was used to set up a petty cash account for daily incidentals (page 5).
