

**DELAWARE MANUFACTURED HOME RELOCATION AUTHORITY  
REGISTERED HOMEOWNERS' ASSOCIATIONS – AS OF MAY 22, 2017  
NOTICE**

Delaware law requires proper registration a of Delaware community homeowner association (“HOA”) with the Delaware Manufactured Home Relocation Authority (“Authority”) for the HOA to be eligible to receive a right of first offer (in appropriate circumstances) when the manufactured home community's owner decides to sell, transfer, or convey all or part of a manufactured home community (a “ROFO”). Registration of an HOA with the Authority is no guaranty or other form of assurance by the Authority that the HOA is entitled to receive a ROFO.
