Delaware Manufactured Home Relocation Authority Financial Summary – Cash Basis September 2018

Revenues

The Delaware Manufactured Home Relocation Authority (the Authority), has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during September 2018 totaled \$13,287.50. Additionally, \$6,162.27 of interest was posted to the Trust Fund in September 2018 for cash held during August 2018.

For the fiscal year, assessments collected totaled \$303,832.82, arbitration fees collected totaled \$1,530.50 and interest received totaled \$11,177.30 (page 4).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$12,454,963.33, total interest received is \$571,843.05, arbitration fees collected is \$23,200.90, and total special collections are \$8,050.00 (page 5).

Expenditures

The Authority paid \$8,000.00 of relocation assistance during September 2018. The Authority paid personnel costs and bills for professional services, office expenses, and utilities during September 2018 totaling \$10,526.80 (page 3).

For the fiscal year, the Authority has paid \$101,500.00 of relocation assistance; \$17,754.10 in personnel costs; \$2,645.08 in occupancy costs; and \$17,314.85 in general and administrative costs (page 4).

Since inception on April 1, 2004, the Authority has paid \$2,400,016.62 of relocation costs; \$433,587.94 in personnel costs; \$82,521.07 in occupancy costs; and \$1,181,455.48 in general and administrative costs, of which \$500.00 was used to set up a petty cash account for daily incidentals (page 5).
