# Delaware Manufactured Home Relocation Authority Financial Summary – Cash Basis December 2018

### Revenues

The Delaware Manufactured Home Relocation Authority (the Authority), has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during December 2018 totaled \$4,645.00. Additionally, \$7,866.14 of interest was posted to the Trust Fund in December 2018 for cash held during November 2018.

For the fiscal year, assessments collected totaled \$587,716.91, arbitration fees collected totaled \$3,530.50 and interest received totaled \$27,687.70 (page 4).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$12,738,847.42, total interest received is \$588,353.45, arbitration fees collected is \$25,200.90, and total special collections are \$8,050.00 (page 5).

## Expenditures

The Authority paid \$3,000.00 of relocation assistance during December 2018. The Authority paid personnel costs and bills for professional services, office expenses, and utilities during December 2018 totaling \$10,534.94 (page 3).

For the fiscal year, the Authority has paid \$133,000.00 of relocation assistance; \$37,737.48 in personnel costs; \$5,006.11 in occupancy costs; and \$29,832.76 in general and administrative costs (page 4).

Since inception on April 1, 2004, the Authority has paid \$2,431,516.62 of relocation costs; \$453,571.32 in personnel costs; \$84,882.10 in occupancy costs; and \$1,193,973.39 in general and administrative costs, of which \$500.00 was used to set up a petty cash account for daily incidentals (page 5).
