Delaware Manufactured Home Relocation Authority Financial Summary – Cash Basis October 2018

Revenues

The Delaware Manufactured Home Relocation Authority (the Authority), has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during October 2018 totaled \$267,180.09. Additionally, \$4,431.52 of interest was posted to the Trust Fund in October 2018 for cash held during September 2018.

For the fiscal year, assessments collected totaled \$571,012.91, arbitration fees collected totaled \$2,030.50 and interest received totaled \$15,608.82 (page 4).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$12,722,143.42, total interest received is \$576,274.57, arbitration fees collected is \$23,700.90, and total special collections are \$8,050.00 (page 5).

Expenditures

The Authority paid \$8,000.00 of relocation assistance during October 2018. The Authority paid personnel costs and bills for professional services, office expenses, and utilities during October 2018 totaling \$9,422.22 (page 3).

For the fiscal year, the Authority has paid \$109,500.00 of relocation assistance; \$23,774.99 in personnel costs; \$3,484.65 in occupancy costs; and \$19,876.61 in general and administrative costs (page 4).

Since inception on April 1, 2004, the Authority has paid \$2,408,016.62 of relocation costs; \$439,608.83 in personnel costs; \$83,360.64 in occupancy costs; and \$1,184,017.24 in general and administrative costs, of which \$500.00 was used to set up a petty cash account for daily incidentals (page 5).
