Financial Summary – Cash Basis
March 2019

Revenues

The Delaware Manufactured Home Relocation Authority (the Authority), has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during March 2019 totaled \$20,110.00. Additionally, \$17,244.45 of interest was posted to the Trust Fund in March 2019 for cash held during February 2019.

For the fiscal year, assessments collected totaled \$905,159.78, arbitration fees collected totaled \$3,530.50 and interest received totaled \$576,900.51 (page 4).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$13,056,290.29, total interest received is \$637,566.26, arbitration fees collected is \$25,200.90, and total special collections are \$8,050.00 (page 5).

Expenditures

The Authority paid \$0.00 of relocation assistance during March 2019. The Authority paid personnel costs and bills for professional services, office expenses, and utilities during March 2019 totaling \$22,793.79 (page 3).

For the fiscal year, the Authority has paid \$142,500.00 of relocation assistance; \$59,195.26 in personnel costs; \$7,740.49 in occupancy costs; and \$60,534.00 in general and administrative costs (page 4).

Since inception on April 1, 2004, the Authority has paid \$2,441,016.62 of relocation costs; \$475,029.10 in personnel costs; \$87,616.48 in occupancy costs; and \$1,224,674.63 in general and administrative costs, of which \$500.00 was used to set up a petty cash account for daily incidentals (page 5).
