Delaware Manufactured Home Relocation Authority Financial Summary – Cash Basis SEPTEMBER 2021

Revenues

The Delaware Manufactured Home Relocation Authority (The Authority), has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during September 2021 totaled \$62,701.57; arbitration fees collected were zero and interested posted to the Trust Fund totaled zero.

For the fiscal year, assessments collected totaled \$265,143.48; arbitration fees collected were \$529.80; and interest received totaled were zero (page 4).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$15,899,113.93; total interest received is \$1,148,356.77; arbitration fees collected of \$11,195.87; and total special collections are \$8,050.00 (page 5).

Expenditures

During the month of September 2021 the Authority paid zero in relocation assistance; \$10,851.23 in personnel costs; \$1983.07 in occupancy costs and \$34,944.63 in general and administrative costs (page 3).

For the fiscal year, the Authority paid \$1,500.00 in relocation assistance; \$29,129.90 in personnel costs; \$5949.19 in occupancy costs; and \$65,991.88 in general and administrative costs (page 4). The Authority has paid \$5,929.14 in capital expenditures and \$1,750 in security deposits (\$1,500 to Keller Williams Realty and \$250 to City of Dover for electric usage which will be returned after 4 years).

Since inception on April 1, 2004, the Authority has paid \$2,445,181.12 in relocation costs; \$722,778.01 personnel costs; \$129,157.18 in occupancy costs; and \$1,655,641.21 in general and administrative costs (page 5).

2021 Compliance Investigation Costs are \$5,442.76 (page 6).

2021 Arbitrator expenses are \$50,023.22 (page 7).
