Delaware Manufactured Home Relocation Authority Financial Summary – Cash Basis APRIL 2022

Revenues

The Delaware Manufactured Home Relocation Authority (The Authority), has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during April 2022 totaled \$189,662.51; arbitration fees collected were zero and interested posted to the Trust Fund totaled zero.

For the fiscal year, assessments collected totaled \$1,032,248.37; arbitration fees collected were zero; and interest received totaled were zero (page 4).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$16,662,096.82; total interest received is \$1,148,356.77; arbitration fees collected of \$10,666.07; and total special collections are \$8,050.00 (page 5).

Expenditures

During the month of April 2022 the Authority paid \$99,522.85 in relocation assistance; \$8,605.14 in personnel costs; \$2,007.41 in occupancy costs; and \$17,177.54 in general and administrative costs (page 3).

For the fiscal year, the Authority paid \$358,434.32 in relocation assistance; \$94,351,70 in personnel costs; \$20,101.83 in occupancy costs; and \$273,327.51 in general and administrative costs (page 4). The Authority has paid \$5,929.14 in capital expenditures and \$1,750 in security deposits (\$1,500 to Keller Williams Realty and \$250 to City of Dover for electric usage which will be returned after 4 years).

Since inception on April 1, 2004, the Authority has paid \$2,802,115.44 in relocation costs; \$787,999.81 in personnel costs; \$141,809.82 in occupancy costs; and \$1,862,976.84 in general and administrative costs (page 5).

2022 Compliance Investigation Costs are \$617.63 (page 6).

2022 Arbitrator expenses are \$47,044.20 (page 7).
