Delaware Manufactured Home Relocation Authority Financial Summary – Cash Basis MAY 2023

Revenues

The Delaware Manufactured Home Relocation Authority (The Authority) has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during May 2023 totaled \$56,743.54; arbitration fees collected were zero and interested posted to the Trust Fund totaled \$26,126.57.

For the fiscal year, assessments collected totaled \$1,075,855.63; arbitration fees collected were zero; and interest received totaled were \$70,644.65 (page 4).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$17,836,847.46; total interest received is \$1,219,001.42; arbitration fees collected of \$8,166.98 and total special collections are \$8,050.00 (page 5).

Expenditures

During the month of May 2023 the Authority paid \$28,800.00 in relocation assistance; \$9,525.72 in personnel costs; \$2,059.37 in occupancy costs; and \$31,532.25 in general and administrative costs (page 3).

For the fiscal year, the Authority paid \$377,100.38 in relocation assistance; \$108,364.59 in personnel costs; \$23,444.35 in occupancy costs; and \$192,924.75 in general and administrative costs (page 4). The Authority has paid \$5,929.14 in capital expenditures and \$1,750 in security deposits (\$1,500 to Keller Williams Realty and \$250 to City of Dover for electric usage which will be returned after 4 years).

Since inception on April 1, 2004, the Authority has paid \$3,272,115.82 in relocation costs; \$913,934.96 in personnel costs; \$169,223.75 in occupancy costs; and \$2,107,606.23 in general and administrative costs (page 5).

2023 Compliance Investigation Costs are \$1,33149 (page 6).

2023 Arbitrator expenses are zero (page 7).
