Delaware Manufactured Home Relocation Authority Financial Summary – Cash Basis JULY 2023

Revenues

The Delaware Manufactured Home Relocation Authority (The Authority) has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during July 2023 totaled \$235,952.47; arbitration fees collected were zero and interested posted to the Trust Fund totaled \$38,768.55.

For the fiscal year, assessments collected totaled \$235,952.47; arbitration fees collected were zero; and interest received totaled were \$38,768.55 (page 4).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$18,084,290.70; total interest received is \$1,288,939.52; arbitration fees collected of \$8,166.98 and total special collections are \$8,050.00 (page 5).

Expenditures

During the month of July 2023 the Authority paid \$18,800.00 in relocation assistance; \$6,909.69 in personnel costs; \$2,005.91 in occupancy costs; and \$3,647.13 in general and administrative costs (page 3).

For the fiscal year, the Authority paid \$18,800.00 in relocation assistance; \$6,909.69 in personnel costs; \$2,005.91 in occupancy costs; and \$3,647.13 in general and administrative costs (page 4). The Authority has paid \$5,929.14 in capital expenditures and \$1,750 in security deposits (\$1,500 to Keller Williams Realty and \$250 to City of Dover for electric usage which will be returned after 4 years).

Since inception on April 1, 2004, the Authority has paid \$3,296,915.82 in relocation costs; \$932,897.44 in personnel costs; \$173,238.41 in occupancy costs; and \$2,123,200.17 in general and administrative costs (page 5).
