

**Delaware Manufactured Home Relocation Authority
Financial Summary – Cash Basis
JULY 2024**

Revenues

The Delaware Manufactured Home Relocation Authority (The Authority) has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during July 2024 totaled \$231,076.47; arbitration fees collected were zero and interest posted to the Trust Fund totaled \$61,567.09.

For the fiscal year, assessments collected totaled \$231,076.47; arbitration fees collected were zero; and interest received totaled were \$61,567.09 (page 4).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$19,208,297.09; total interest received is \$1,776,751.55; arbitration fees collected of \$8,166.98 and total special collections are \$8,050.00 (page 5).

Expenditures

During the month of July 2024 the Authority paid \$6,500.00 in relocation assistance; \$9,546.67 in personnel costs; \$2,091.22 in occupancy costs; and \$5,838.81 in general and administrative costs (page 3).

For the fiscal year, the Authority paid \$6,500.00 in relocation assistance; \$9,546.67 in personnel costs; \$2,091.22 in occupancy costs; and \$5,838.81 in general and administrative costs (page 4). The Authority has paid \$5,929.14 in capital expenditures and \$1,750 in security deposits (\$1,500 to Keller Williams Realty and \$250 to City of Dover for electric usage which will be returned after 4 years).

Since inception on April 1, 2004, the Authority has paid \$3,422,621.71 in relocation costs; \$1,055,756.80 in personnel costs; \$198,697.66 in occupancy costs; and \$2,315,794.90 in general and administrative costs (page 5).

2024 Compliance Investigation Costs total \$2,907.24 (page 6).

2024 Arbitrator expenses are \$615.00 (page 7).

2024 Board Member Stipend Costs total \$1,665.00 (page 8).

2024 Petty Cash expenses balance is \$381.67 (page 9).
