# Delaware Manufactured Home Relocation Authority Financial Summary – Cash Basis SEPTEMBER 2024

#### Revenues

The Delaware Manufactured Home Relocation Authority (The Authority) has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during September 2024 totaled \$7,526.50; arbitration fees collected were zero and interested posted to the Trust Fund totaled \$67,970.77.

For the fiscal year, assessments collected totaled \$264,398.98; arbitration fees collected were zero; and interest received were \$196,673.71 (page 4).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$19,241,619.60; total interest received is \$1,911,858.17; arbitration fees collected of \$8,166.98 and total special collections are \$8,050.00 (page 5).

### **Expenditures**

During the month of September 2024 the Authority paid \$100.00 in relocation assistance; \$9,780.46 in personnel costs; \$2,120.39 in occupancy costs; and \$8,298.76 in general and administrative costs (page 3).

For the fiscal year, the Authority paid \$6,600.00 in relocation assistance; \$33,979.38 in personnel costs; \$6,342.80 in occupancy costs; and \$41,459.18 in general and administrative costs (page 4). The Authority has paid \$5,929.14 in capital expenditures and \$1,750 in security deposits (\$1,500 to Keller Williams Realty and \$250 to City of Dover for electric usage which will be returned after 4 years).

Since inception on April 1, 2004, the Authority has paid \$3,422,721.71 in relocation costs; \$1,080,189.51 in personnel costs; \$202,949.24 in occupancy costs; and \$2,351,415.27 in general and administrative costs (page 5).

2024 Compliance Investigation Costs total \$3,023.96 (page 6).

2024 Arbitrator expenses are \$1,065.00 (page 7).

2024 Board Member Stipend balance is \$3,500.00 (page 8).

2024 Petty Cash expenses balance is \$369.67 (page 9).
