Delaware Manufactured Home Relocation Authority Financial Summary – Cash Basis NOVEMBER 2024

Revenues

The Delaware Manufactured Home Relocation Authority (The Authority) has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during November 2024 totaled \$24,068.78; arbitration fees collected were zero and interested posted to the Trust Fund totaled \$42,961.44.

For the fiscal year, assessments collected totaled \$536,997.93; arbitration fees collected were zero; and interest received were \$306,051.56 (page 4).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$19,509,718.55; total interest received is \$2,021,236.02; arbitration fees collected of zero and total special collections are \$8,050.00 (page 5).

Expenditures

During the month of November 2024 the Authority paid \$24,303.00 in relocation assistance; \$9,764.32 in personnel costs; \$2,431.91 in occupancy costs; and \$33,418.01 in general and administrative costs (page 3).

For the fiscal year, the Authority paid \$30,903.00 in relocation assistance; \$53,476.36 in personnel costs; \$10,781.31 in occupancy costs; and \$81,331.50 in general and administrative costs (page 4). The Authority has paid \$5,929.14 in capital expenditures and \$1,750 in security deposits (\$1,500 to Keller Williams Realty and \$250 to City of Dover for electric usage which will be returned after 4 years).

Since inception on April 1, 2004, the Authority has paid \$3,447,024.71 in relocation costs; \$1,099,686.49 in personnel costs; \$207,387.75 in occupancy costs; and \$2,391,287.59 in general and administrative costs (page 5).

2024 Compliance Investigation Costs total \$3,023.96 (page 6).

2024 Arbitrator expenses are \$1,280.00 (page 7).

2024 Board Member Stipend balance is \$2,700.00 (page 8).

2024 Petty Cash expenses balance is \$268.34 (page 9).
