## Information About the CPI-U

The CPI-U is a price index released by the Bureau of Labor Statistics. The 36 month period of 1982 - 1984 = 100 (base). More information about this data product is available at http://www.bls.gov/cpi/. The CPI-U for the Philadelphia metropolitan area is released every other month. It is also not available seasonally adjusted.

The 12-month percent change as reported by BLS is only reported to one post decimal digit. The index itself is reported to three post decimal digits. To increase the detail in this report, the 12-month percent change is calculated from the index to three post decimal digits. The 24-month percent change is calculated by computing the average between the current year's 12-month percent change and the previous year's 12-month percent change. For example, if the current year is 2023, you add the 2023 12-month percent change, divide by two, and round the answer to the nearest three decimal points.

The CPI-U for the Philadelphia/Wilmington/Atlantic City metro area will next be released by the Bureau of Labor Statistics (BLS) on May 14, 2025 for April 2025 and the CPI-U report will be provided by DSHA within five days of release.

In accordance with SB 317, signed June 30, 2022, the CPI-U is, effective 7/13/22, reported as the 24-month CPI-U.
