Delaware Manufactured Home Relocation Authority Financial Summary – Cash Basis SEPTEMBER 2025

Revenues

The Delaware Manufactured Home Relocation Authority (The Authority) has a Trust Fund administered by the Delaware Division of Revenue. As shown on page 3, assessments collected during September 2025 totaled \$1,195.50; arbitration fees collected were zero and interest posted to the Trust Fund totaled \$59,772.44.

For the fiscal year, assessments collected totaled \$1,132,676.94; arbitration fees collected were zero; and interest received were \$880,167.46 (page 4).

Since inception on April 1, 2004, the Authority has collected assessments totaling \$20,109,897.56; total interest received is \$2,595,351.92; arbitration fees collected is \$8,166.98 and total special collections are \$8,050.00 (page 5).

Expenditures

During the month of September 2025 the Authority paid \$45,049.82 in relocation assistance; \$10,978.13 in personnel costs; \$2,280.50 in occupancy costs; and \$4,857.00 in general and administrative costs (page 3).

For the fiscal year, the Authority paid \$445,819.12 in relocation assistance; \$165,510.72 in personnel costs; \$33,203.30 in occupancy costs; and \$258,581.85 in general and administrative costs (page 4). The Authority has paid \$5,929.14 in capital expenditures and \$1,500 in security deposit to Keller Williams Realty.

Since inception on April 1, 2004, the Authority has paid \$3,861,940.83 in relocation costs; \$1,211,720.85 in personnel costs; \$229,809.74 in occupancy costs; and \$2,568,537.94 in general and administrative costs (page 5).

2025 Compliance Investigation Costs total \$1,929.29 (page 6).

2025 Arbitrator expenses are \$725.00 (page 7).

2025 Board Member Stipend balance is \$3,00.00 (page 8).

2025 Petty Cash expenses balance is \$459.01 (page 9).
